This year's **Annual Audit Reporting** is complete with 95% of parishes and schools able to complete the report. OPCY will continue to work with those parishes and schools that had difficulty with the Report in order to get the necessary information for compliance.

Thank you to all the people in our parishes and schools that worked so hard to get the Report in on time!

Those parishes with trained Site Administrators were able to provide their compliance data much easier than those without a trained person on site. The Safe Environment Office offers training on a regular basis. If your parish or school does not have a trained Site Administrator, contact Mayra Flores at 312-534- 5238 for information on the next training date or go to Training for more information.

The Archdiocese requires all clerics, all employees, and all volunteers who work with children to undergo training and background checks. The process for background checks begins with eApps Registration

Remember State Law requires all school employees to be fingerprinted.

What if a child discloses?

This question is a concern of many people after attending a training class. Disclosure: telling someone what you experienced, sharing a secret... a process that is scary for the victim-survivor, and can be stressful for the person hearing the story, when the secret is abuse. How do you best react when you hear of abuse to facilitate healing? How does your reaction differ if the person is a child, a SPRED participant, a vulnerable adult? What is your role as a teacher, a catechist, a youth minister? How do you deal with your own feelings?

Responding with loving compassion and reporting the disclosure to the proper state authorities are the keys to fulfilling these goals. For more information log on to the <u>Virtus site</u> Find **Resources** on the left menu under **Educators** tab.

Protecting God's Children

This training program teaches adults to spot grooming behavior in adults who may attempt to harm our children. Common warning sign behaviors include adults who:

- Discourage other adults from participating
- Show a preference for being alone with children
- Give gifts, often without permission
- Wrestle, tickle, or are excessively physical with children,
- Use bad language, tells "dirty" jokes, "accidently" show children pornography
- Think the rules do not apply to them.

The Protecting God's Children training teaches adults to **Communicate Concerns** if they witness these behaviors. If a parent reports such concerns, we must learn to take them seriously and follow up with that information.
